Sr No	Requirements
1	The " Bidder " can be a single Bidder bidding on its own. A person cannot submit multiple Bids as a single Bidder to qualify technically, Bidder shall satisfy all the following minimum threshold criteria prescribed in this Clause.
2	A Bidder blacklisted by any Government Organization will stand disqualified. Action such as termination/foreclosure of contract on account of non-performance of contractual obligations should not have been taken against bidder. The bidder should not have been proved guilty conclusively in the ongoing inquiry/investigation by Directorate of Revenue Intelligence (DRI), Government of India (GOI) or any other GOI investigation agency in the matter of alleged fraud of over-invoicing of imported coal.
3	The Bidders complying with the following requirements:
i	Bidder may have to submit the Bill of Lading copies to evidence their experience of minimum 1 Lakh MT per year of Coal in the last three financial years of non-coking steam (thermal) coal.
ii	Details of orders executed, with quantity and value, together with name and address of their customers with email/ Telephone No. are to be attached.
iii	Bidders shall submit experience certificates from their customers for their satisfactory performance in support of their offers
iv	Bidder may have their own/rented/leased stockyard other than the port facilities and should submit their proof.
4	Tendering Quantity: Bidders may offer 100% of the total Tender Quantity as indicated in Scope of Work below and shall have to accept the delivery schedule as per the requirements of GNAL.
5	Bidder should have experience of Vessel loading/unloading and surface transportation in India.
6	The Bidder must demonstrate sound financial status as defined in this Clause to the satisfaction of GNAL. Documentary proof including copies of audited annual accounts for the last three financial years (i.e. F.Y. 2019-20 to 2021-22), of the Bidder shall be attached. The Documentary proof shall include without limitation:
i	Audited Financial Accounts
ii	List of Banks (RBI scheduled banks only) from which references can be obtained with the contact details i.e. Address, Telephone Nos and email. Listing of Bankers shall be deemed an authorization by the Bidder for GNAL to request such references and for the bankers to release them to GNAL.
iii	The Bidder, shall have to meet the threshold criteria that the annual accounts of the Bidder for each of the last three financial years (i.e. F.Y. 2019-20 to 2021-22) shall reflect positive Net Profit and Net Worth and average annual turnover of minimum Rs. 100 crores as reflected in the Balance Sheets of the Bidder in last 3 financial years.
7	The Bidder notwithstanding anything stated above, GNAL reserves the right to assess the credibility, capability and capacity of the Bidders to perform the Contract should circumstances so require, such an assessment being in the overall interest of GNAL.
8	GNAL also reserves the right to seek such additional information as it may deem fit to satisfy itself of the eligibility of the Bidder.
9	The Bidder shall furnish all such additional information and other documents to GNAL as may be required from time to time by GNAL. Any failure to do so shall lead to rejection of the Bids by GNAL.
10	All experience certificates furnished by the Bidders pursuant to their Bids shall be duly authorized by authorized person of company/organization.
11	GNAL reserves the right to accept or reject the request of issue of tender without giving any reason thereof.
12	The Bid of interested parties shall only be accepted for those bidders who have purchase tender document by paying Tender Fees.
